Restoring Hope, Rebuilding Lives

Cuan Mhuire is Ireland's largest provider of addiction treatment services and residential rehabilitation. With its holistic approach, the organisation addresses the psychological, emotional, and social facets of addiction, operating across five treatment centres and seven transition houses across Ireland. We offer a variety of programmes from detoxification to residential treatment and aftercare services. We champion a therapeutic community approach, enhanced by individual counselling, family support services, and an emphasis on personal responsibility.

For over five decades, Cuan Mhuire has welcomed anyone seeking a new life away from addiction, which indiscriminately affects people from all walks of life. From 2015 to 2022, there was a 35% increase in individuals seeking treatment for drug and alcohol use, with 2023 marking an 12% surge in demand for Cuan Mhuire's services.

Sr Consilio's core belief in the innate goodness and potential for change and healing in each person continues to guide our mission, reminding us of the transformative power of community and support in the journey to recovery.





CEO ADDRESS 2023

Introducing Cuan Mhuire's 2023 Annual Report as CEO, I have been reflecting on the vital work that Sr. Consilio began almost 60 years ago, and which has continued over the years in helping people throughout the country who suffer from addiction. Today Cuan Mhuire continues to support people to discover their innate goodness and giftedness, even in the midst of their daily struggles with addiction. The Cuan Mhuire programme provides hope to many who are in despair and provides a journey of recovery for those unable to see a way forward.

Cuan Mhuire is also extremely concerned for the suffering that families experience who have loved ones in addiction. Their pain can so often be overlooked when the focus is on the addicted individual. Consequently, Cuan Mhuire is available at all times to respond to the family's needs and is eager to reach out and support any and all family members.

In 2023, occupancy levels in Cuan Mhuire have continued to rise very significantly and the demand for places in Treatment Centres is higher than ever with a 12% increase in admissions. Throughout the year, Cuan Mhuire provided 170,395 bed nights across our five Residential Centres and 29,862 bed nights in our Transition Houses. These bed night numbers represent an approximately 12% increase on the 2022 figures and reflect our continuing commitment to our service users and to providing a quality service to our residents and to their families.

Cuan Mhuire considers Aftercare to be an essential component of recovery for our residents once they have completed their Treatment Programme. We are very pleased then to report that in 2023 the attendance numbers at our Aftercare centres increased by 35% on 2022 figures to 17,527. This indicates to us that that our ex-residents are becoming more aware that Aftercare has such a vital role to play in their recovery.

A number of significant developments have taken place in Cuan Mhuire throughout the year. In response to the emerging gambling crisis in Ireland, Cuan Mhuire, in conjunction with Gambling Awareness Trust, opened our second residential treatment service for gambling addiction, a new twenty bed unit in Bruree. This represents a significant expansion on the gambling specific treatment programme already operational in Cuan Mhuire Athy and it provides recovery opportunities for in excess of eighty clients per annum. Since then, Galway also now provides a gambling specific treatment programme. These services provide support for individuals and families in crisis throughout the country who would otherwise not have been able to access a gambling-specific programme.

Another significant development this year for Cuan Mhuire has been the completion of twelve apartments for long term residents in Cuan Mhuire Newry and this will greatly enhance our services for those who need them. As part of our continued commitment to quality improvement, Cuan Mhuire has been accredited with CHKS and ISO certification. We are pleased to report that in 2023, site surveys in Bruree, Farnanes and the Western Road

in Cork have all once again fully achieved the standard required to maintain Cuan Mhuire's accreditation.

As Cuan Mhuire is committed to providing affordable addiction treatment for so many individuals throughout the country, there continues to be a significant strain on our day to day running costs. In particular, increases in energy and food costs pose a particular challenge as we strive to provide the best possible service for our residents. In our efforts to maintain the existing level of service, Cuan Mhuire needs to engage in significant fundraising initiatives over the coming years. As a consequence of this, the Cuan Mhuire Board has approved a decision to engage Consilium and its Managing Partner, James O'Murthuile, to develop a strategic plan for Fundraising, as well as to hire a Fundraising Manager to work on various projects. Both of these initiatives were begun in late 2023 and an initial assessment of what is needed going forward is expected by the middle of 2024.

A very significant challenge also for Cuan Mhuire is that, due to the ongoing housing crisis in the country, it is becoming increasingly difficult for our residents to find accommodation once they leave our Treatment Centres or Transition Houses. There is an acute lack of availability of social housing and rental accommodation, and this is particularly challenging for single men.



Once again, I must express my gratitude to the Board of Directors for their role in guiding the development of Cuan Mhuire's services, and for their ongoing support for me throughout the year. The commitment and dedication of our staff and volunteers throughout the country has again been exemplary over the past year in their service towards all who use our services. I would also like to thank the statutory agencies that support Cuan Mhuire as well as our benefactors who help us to maintain our range of services for those who seek our support. Finally, I have no doubt that in 2024 all in Cuan Mhuire will continue Sr Consilio's mission to serve the needs of those who suffer from addiction and their families "always attentive to providing the highest standards of excellence for those to whom we provide care and support."

Chairman's Statement 2023

2023 saw Cuan Mhuire return to pre-Covid level of admissions and now has full occupancy. Indeed, such is the demand for the services of Cuan Mhuire that waiting lists continue to grow, which is certainly a cause of concern. Every effort is made to facilitate all of those who seek to avail of the facilities of Cuan Mhuire. Whilst staff recruitment is for us, like many other organisations an ongoing challenge nonetheless, we remain extremely active in our endeavors to recruit staff and I am glad to report that our recruitment drive has proven successful, and we continue to maintain adequate staffing levels. Indeed, it would be remiss of me were I not to extend my sincere gratitude to all of our staff who remain particularly committed and hard working.

The ever-increasing costs in providing our services is the greatest challenge which we now face, and we continue to liaise with our statutory funders to highlight the reality that the funding we receive needs to be adequate to meet the ongoing day to day running costs of Cuan Mhuire. Needless to say, we are extremely grateful for the funding and support we receive from the funding bodies but nevertheless, I am obliged to highlight the fact that the funding we receive must reflect the realities of the ever-increasing resources required to allow us to continue to provide the highest level of services.

Though we have financial constraints in the day to day running of our services, nonetheless, each of our houses must be commended for their efforts in continuing to strive to improve facilities and thanks to the generosity of our donors and the assistance of statutory authorities.

The following is a brief outline of some developments in the recent past and proposed developments which we hope to progress in the near future.

1. Cuan Mhuire, Coolarne, Co. Galway

- a. Completed painting of entire external of treatment Centre and out-houses.
- b. Completed upgrade of heating system.
- c. Refurbished 19 bedrooms.
- d. Introduction of a 20-week drug programme and a new gambling specific programme.
- e. Plan to refurbish Detox Unit.
- f. Plan to expand Garden Centre activities.

2. Cuan Mhuire, Newry, Co. Down

- a. The construction of 12 two bedroomed long-term apartments have been completed and will be available for occupation in the immediate future with the official opening scheduled for the 28th of June 2024 and at which time the 40th Anniversary of the establishment of Cuan Mhuire in Newry will be celebrated.
- b. The installation of a state-of-the-art Residents gym.

3. Cuan Mhuire, Athy, Co. Kildare

- a. Major refurbishments are planned for Our Lady's Drug Unit and the Detoxification Unit in the main house.
- b. In the Sr. Consilio Centre, our Horticulturist has developed the grounds which includes polytunnels in which we will grow our own vegetables.
- c. Ongoing maintenance in the Athy Centre including replacing the carpets with marmolium flooring.

4. Cuan Mhuire, Farnanes, Co. Cork

- a. The Coffee Bar/Reception area has been redecorated and upgraded with the installation of two large patio doors with triple glaze glass.
- b. Three of the apartments have been redecorated and upgraded.
- c. A new boiler has been installed in the Detoxification Unit.



- d. The Oratory has been redecorated.
- e. In the course of 2024, it is hoped to install a new phone system and the internet access will be improved. Also, a new security system is to be installed.

5. Cuan Mhuire, Bruree, Co. Limerick

- a. 2023 saw a continuation of the reconstruction work, which was commenced in 2022 at Cuan Mhuire, Bruree. The Northwest Wing ground floor and the first floor of the Southwest Wing were reconstructed and upgraded and are now ensuite.
- b. Extensive improvement works have been undertaken in the Ladies Unit which include the reconstruction of the dining room and the construction of a large conservatory.
- c. Works are ongoing on the Northeast Wing, and it is anticipated that these works will be completed in the coming weeks.
- d. A Gambling specific programme was introduced in January 2023. There were 89 admissions to the programme during the course of that year. Three of the staff in Bruree did the Certificate in Problem Gambling Addiction (NFQ Level 8) course which is provided at Galilee House of Studies, Athy, Co. Kildare by Cuan Mhuire in conjunction with MTU. I would like to acknowledge the tremendous support which Cuan Mhuire receives from the Gambling Awareness Trust.

As is outlined above, every effort is made to continue to improve Cuan Mhuire facilities across the country as we endeavour to maintain the highest possible standards in every respect.

We had the great pleasure some weeks ago to celebrate a special occasion for Sr. Agnes who is now over 40 years at Cuan Mhuire, Bruree and she continues to work tirelessly to enhance the facilities at Cuan Mhuire, Bruree even further.

I am delighted to report that Sr. Consilio continues to lead Cuan Mhuire with all her enthusiasm and determination as has always been the case and she continues to be an inspiration and a source of huge motivation for all involved in Cuan Mhuire.

I cannot speak highly enough of our house leaders, staff and volunteers whose commitment and dedication has made Cuan Mhuire the successful organisation which it is.

May I offer my sincere gratitude to my fellow Directors whose expertise, knowledge and commitment to Cuan Mhuire is invaluable and we are extremely fortunate to have a Board of Directors who bring to the organisation vast experience and knowledge from a wide variety of sectors in our society.

I would also wish to extend our gratitude to our funding bodies which include the Health Service Executive, Supporting People-NIHE, HSCB/DoH, various City and County Councils, the Department of Justice and Equality and Private Healthcare Providers. As I have mentioned on a number of previous occasions, without these funding bodies, Cuan Mhuire could not function, but I earnestly hope that even further assistance can be furnished so that we can meet the challenges ahead and the ever-rising costs in providing our services on a daily basis.

May I also thank most sincerely our many benefactors and friends of Cuan Mhuire who continue supporting the organisation and without whom, Cuan Mhuire could not function or maintain the services provided.

Like many other organisations, Cuan Mhuire has come through and survived all of the difficulties posed during the Covid period and I am glad to report that post Covid Cuan Mhuire is a stronger organisation, continuing to expand and provide enhanced facilities and treatment services.

May I conclude by thanking all who support Cuan Mhuire in any way to enable us to continue to provide the services that are so essential to our society.


Why Cuan Mhuire is Special

Cuan Mhuire Organisational Chart



Cuan Mhuire Services

- A comprehensive assessment
- Detoxification
- Treatment
- 2 Year+ Aftercare
- Supported accommodation and associated services where necessary.
- Family Support
- Outreach Programme to schools, community groups etc.
- Friends of Cuan Mhuire A Support Network

The Residential Treatment Programme is provided by a multi-disciplinary team qualified and experienced in addiction treatment. The programme includes:

- Group Therapy
- Individual Counselling
- Meditation and relaxation therapies
- Videos and Lectures
- Therapeutic duties to develop responsibility, to foster coping skills, to encourage reaching out and sharing.
- AA, NA and GA Meetings
- Alternative Therapies Art Therapy, Aromatherapy, Pottery, Woodwork etc.
- Personal Development Classes
- Family Conferences
- Family Day Meetings
- Family Support Groups
- Where applicable, assisting in finding accommodation/supported accommodation and services on completion of the programme.








Admission by Age Profile





Transition Housing Admissions by Age 2023







Quality Services Accreditation

All Cuan Mhuire treatment centres and Supported Accommodation have CHKS accreditation and ISO certification.

In 2023 ISO took place with CHKS surveyors, surveying our centres, in Bruree, Fernanes and Western Road Cork. All criteria were fully met, and we were awarded Accreditation and ISO 9001-2015. CHKS also issued a report on their findings.

The following is a quote from the report. "Cuan Mhuire is a dedicated organisation, providing high quality care and empowerment to those who participate in the treatment programmes.

Internal Auditing

Cuan Mhuire has a comprehensive annual audit schedule in place. The audit schedule consists of both non-clinical and clinical audits which are routinely carried out to ensure continuity of high standard of service delivery and care. Additional/new audits are introduced as and when the need arises. Non-clinical audits carried out during 2023 include catering services, housekeeping services, service users' feedback surveys, HR personnel, Fire safety, health and safety practices, staff feedback survey. Clinical audits carried out during 2023 include Risk management - accidents/incidents/near misses, complaints, infection control, hand hygiene, waste management (non-clinical and clinical), clinical records, medication management, access and waiting times, assessment, discharges (programme completion and early discharges), re-admission, care pathways, care plans, aftercare, resident feedback surveys. Audit findings are collated, reviewed and provide an opportunity to implement changes to practices and/or introduce remedial measures in collaboration with various departments and services throughout the Organisation. An Organization-wide standardized approach to audit planning and audits carried out allows for benchmarking of practices across all Cuan Mhuire sites and enhances quality and consistency of service delivery and care provided. Governing bodies and senior management rely on internal auditing for objective assurance and insight on the effectiveness and efficiency of governance, risk management and control processes.

Risk Management

Cuan Mhuire has an integrated approach to managing risk. The risk management process deals with all kinds of risks regardless of whether they are clinical, organisational, operational, health and safety or financial. It has appropriate systems and processes in place to support the implementation of its risk management strategy. Each centre has a health and safety officer, a health and safety representative, and a clinical risk manager. Relevant health and safety developments and information are fed back in a timely manner to staff through our health and safety committees, local leadership meetings and staff meetings. Risk is monitored on an ongoing basis. Two key performance indicators are utilised. The first relates to adverse events. In 2023 there were a total of 211 adverse events reported across the organisation. Of those 29 were classified as near misses,166 as minor incidents, 15 moderate and 1 as serious. A second indicator is complaints. There were 19 written complaints received during 2023. All complaints were satisfactorily resolved. It is the policy of Cuan Mhuire to provide quality treatment and care to its residents in a caring and safe environment.



Training and Education

Education

Cuan Mhuire in partnership with Munster Technological University (MTU) provides a BA Honors Degree course in Addiction Counselling at Galilee House of Studies, Athy Co. Kildare.

Cuan Mhuire has an agreement with Munster Technological University (MTU) to deliver a Level 8 specialist training programme "Recognising and Responding to Problem Gambling" at Galilee House of Studies, Athy. Two courses were run over the year with approx..30 completing the course successfully.

Financial Report 2023

Income

Consistent with previous years State funding, which is subject to service level agreements, accounts for one third of total income. The largest source of income is the contribution of the Charity's service users which grew by 23% year-on-year. The near capacity occupancy levels are testament to the ever-growing demand for addiction treatment services. The balance of income in the year came from our restaurant, garden centres, and farms. The generosity of donors and fundraisers and support of the Gambling Awareness Trust are also crucial.



Expenditure

Payroll continues to be the most significant cost heading, at just less than half of total overheads. The task of recruiting and retaining high calibre, qualified professionals coupled with the impact of current wage inflation levels is challenging. Though stabilising, the Charity continued to be impacted by energy price inflation. General inflation, across a wide range of goods as well as services contributed to a 14% uplift in expenditure in the year.



Highlights of 2023

Cuan Mhuire Bruree

In April 2023, Cuan Mhuire, in conjunction with The Gambling Awareness Trust, opened its second residential treatment service for gambling addiction, a new twenty bed unit in Bruree. This represents a significant expansion on the gambling specific treatment programme already operational in Cuan Mhuire Athy and it provides recovery opportunities for in excess of eighty clients per annum. Since then, a third unit in Cuan Mhuire Galway now provides a gambling specific treatment programme. These services provide support for individuals and families in crisis throughout the country who would otherwise not have been able to access a gambling-specific programme.

Cuan Mhuire Newry Long Term Supportive Accommodation Apartments



Cuan Mhuire Newry completed the construction of 12-two-bedroom apartments in December 2023. This accommodation will provide urgently needed support for those who are homeless or for those who need more time as part of the continuum of support that sustains recovery and minimises relapse. Prior to this the situation was that once residents had completed our 12-week residential programme they were discharged in order that there was access for new residents.

The Residents that choose to live in these apartments will be able to avail of our full range of services which will enhance their chances of recovery and slowly they can ease themselves back to independent living in the community.



Cuan Mhuire Newry GYM

It is no secret that physical activity really benefits an individual's physical and mental health. Regular exercise at the beginning of recovery can be instrumental for people in residential treatment. Many treatment facilities incorporate exercise into their programs for this very reason.

Therefore, in September 2023, Cuan Mhuire Newry opened its new state of the art GYM, providing a structured health and well-being exercise program for its Residents in partnership with a fully qualified GYM instructor.

When people use drugs and or alcohol in excess, their body and mind are both impacted. Addiction changes your body chemistry. Once substances are removed, it is likely many will be left feeling anxious, depressed and sensitive to some of life's major stressors. The good news is that physical activity can help shift the tide on those negative emotions and bring some positive results.

We are delighted to report that over 70% of Resident's are participating in regular exercise whilst in Cuan Mhuire with many proven benefits being encountered by the residents such as (Improved Mood, Increased Energy, Better Sleep and Reduction in Stress).





Cuan Mhuire Coolarne



2023 brought many changes for Cuan Mhuire, Coolarne. In response to the growing demand for drug treatment beds in the West, we rolled out the 20 weeks drugs programme. In May we responded to the growing number of individuals presenting with problematic gambling and rolled out the new Gambling Specific Programme. In the Autumn, we responded to the growing waiting times for admission and upgraded the heating system in an old part of the building, renovated single bedrooms and installed additional WC facilities creating ten additional drug treatment beds.



Cuan Mhuire Farnanes Fashion Show

On 16 November 2023, Silk Peaches Boutique in Ballincollig held a fundraiser in aid of Cuan Mhuire, Farnanes. This marks the second consecutive year that Silk Peaches Boutique has supported Cuan Mhuire by organizing a fashion show. The Trade House Bar/Restaurant in Ballincollig supported the fashion show by providing the venue. Many local businesses showed their support by donating spot prizes for the raffle on the night. Both professional models and local individuals volunteered their time to model a wide range of fashionable clothing. Like last year, it was a huge success and greatly appreciated by those in Cuan Mhuire Fernanes and a great night was had by all.







A Residents Story- Jenny

Hi, my name is Jenny, and I am an alcoholic.

I come from a family of 7. The family was made up of Mum, Dad and 4 siblings. Looking back at my family history I know that both my maternal and paternal grandfathers suffered from alcoholism, however neither of my parents were alcoholic. Dad worked hard as did my mum – and my home was busy. During my childhood I never felt a sense of belonging and so this basic need was not met. This led to me feeling inferior and out of place in school. Home life was somewhat in that it was different, I was the "favourite" child and my parents relied on me heavily to ensure that the family unit was keeping up appearances, so to speak. This resulted in me feeling a huge sense of responsibility and pressure from a very young age. Home life was far from perfect. From the age of 10 to 12 I was abused by a family member, the trauma from this unbeknownst to me at the time would be lifelong. I discovered alcohol at 14 and instantly felt free from all of my fears – it was pure escapism. I left home at the age of 17, moving to Europe which suited me well, as everyone around me was drinking and partying. I then did another geographical, this time to England in 1998 where I met my future husband. Alcohol became a major complication for me following the birth of my own children. Through my recovery journey I came to understand that the trauma caused from childhood abuse, that I thought I had repressed, had in fact resurfaced. As the children grew older, the more my fears and anxiety around childhood abuse increased and became unmanageable. I returned home to Ireland to be closer to my parents, however devastatingly my mother died two years after I returned. This is when my alcoholism really progressed as I had no coping mechanism in place to cope with the death of my mother or the grieving process that was to follow. For me drinking became a survival technique and my new norm.

Before agreeing to participate in the rehabilitation programme in Cuan Mhuire I had tried every method known to man to break free from alcohol. So, just over a year ago I made the decision to go to Cuan Mhuire, this was it my last resort and my last chance to build a new life for my family and myself. Going into Cuan Mhuire was the best decision I ever made. The support I received was second to none, what made it even more effective was the fact that some of the staff are in recovery themselves – this was crucial in building a rapport with staff and being able to trust people again. My time in Cuan Mhuire was a life changing experience which hasn't just changed my life but also the lives of my entire family. The aftercare support that is provided to both me and my family is such an important part of maintaining my recovery. In order to show my gratitude to Cuan Mhuire for the life it has given me I now volunteer there, to give back to them what was so freely given to me.

Ultimately, Cuan Mhuire has saved my life. It provided me with a foundation on which I could start to rebuild my life upon. Without the services Cuan Mhuire provides I honestly don't know if I would still be alive today and for that I will be forever grateful.



A Residents Story-Peter

My name let's just say is Peter, I am 43 years old.

Two years ago, I decided it was time to find recovery and take back my life from the grip that drug addiction had on my life.

Before I went into the drug unit in Cuan Mhuire, Bruree I was a broken man in every sense. Mentally, emotionally, physically, financially I was ruined. I was left homeless on the streets of Limerick City. But the hardest emotion to deal with was the affect my addiction had on my two children.

My story on recovery.

I can honestly say the best decision I ever made was to go into Bruree for treatment for my drug addiction. I was totally petrified of my journey ahead as I had suppressed myself with drugs most of my adult life, but I was determined to get well not only for myself but also for my children. My experience of the drug unit and the programme for the five months has nothing but a positive outcome on my life. I learned so much about myself through the group therapy, but it was the one-to-one counselling that I really got healing through as I was able to share things that I felt ashamed of and could not share in a group. The discipline of the programme I found really beneficial as I took pride in myself for the first time in many a year, getting up early, making my bed, keeping my room tidy, eating at regular times were things that I had no interest in before I began my treatment. My Family Conference experience was a real eye opener for me — listening to my two daughters share their experience of the affects my addiction had on their young lives but I am so delighted we had the meeting as my girls have said they got some healing through the meeting, and it also is helping me to stay sober as I never again want to hurt them.

My life today.

When I finished the programme, I went into Teach Mhuire Cork Transition House as I did not want to go back to Limerick City. The transition house in Cork has a great setup for its residents. They got me on a Community Employment Scheme for twelve weeks where I did personal development courses, computer classes and I got my forklift driving license. I am now twenty months sober, in full-time employment as a warehouse manager. I have moved on from the transition house and currently live in my own apartment. I also have my daughters back in my life which I am so grateful for.

I'd like to say thank you to Sr. Agnes and all her staff for their help, kindness and guidance.
